It was agreed that the minutes of the Council meeting were a true record and were duly signed off by Cllr. Howe (Proposed Cllr. Howe, seconded Cllr. Singer).

23/06 Neighbourhood Plan

The following documents were received:

- Broomhaugh & Riding Neighbourhood Plan Submission Draft
- Local Green Space Background Paper
- Housing Background Paper
- Schedule of comments received on the pre-submission draft plan

It was noted that the main updates to the earlier consultation draft were to the Natural Environment section and the removal of the Riding Farm site as a separate planning policy as the proposed development had recently received planning permission.

Cllr. Irwin queried why two appendices had been added to the Plan which he felt were unnecessary. One appendix provided a summary of the Grade II listed buildings and structures within the parish. He felt that the list was incomplete and therefore the selection needed to be clearly defined. He suggested a better solution was to provide a link to Historic England's website which would provide a full up-to-date list. He also felt it unnecessary for there to be an additional appendix summarising the natural environment of the parish.

However, his greatest concern was that a seventh objective had been inserted which he felt made the plan unbalanced and which seemed to give too much emphasis to the natural environment over other topics.

After much discussion it was agreed that these objections were valid and that the Submission Plan should be approved subject to the following conditions:

- 1. That the Natural Environment objectives should be merged;
- 2. That the Grade II Listed building schedule should be replaced by a weblink;
- 3. That the additional summary of the natural environment of the parish should be included as either a separate paper or as an appendix to the Local Green Space Background paper.

This was proposed by Councillor Howe, seconded by Councillor McKenzie and unanimously agreed.

Councillors also approved the Local Green Space Background Paper (Proposed Cllr. Howe, seconded Cllr. Dunhill) and the Housing Background Paper (Proposed Cllr. Howe, seconded Cllr. McKenzie). Cllr. Howe reported that the Broomhaugh development site had been removed from the proposals as required by the County Council as the land was within the green belt and the Local Plan included no provision for the strategic review of the green belt.

The schedule of comments received on the pre-submission draft plan was received and actions noted.

It was confirmed that once the updates were made, the Plan would be submitted to the County Council to ensure that all due processes had been completed before NCC would appoint an independent examiner to assess the plan.
